HOW TO ESTIMATE YOUR TAXES **

DIVIDE PURCHASE PRICE BY 2
MOVE DECIMAL TO LEFT 3 SPACES
MULTIPLY BY SCHOOL LEVY

EXAMPLE

**COST \$200,000.00 ÷ 2 =
100,000.00 LEFT 3 SPACES
100 X 28.9708 = \$2,897.08**
